Dear Parent/Carer,

Mudgeeraba Special School prides itself on being SunSmart by encouraging students to play in the shade, wear sun safe clothing including a hat and apply sunscreen. Throughout your young person's school programs, it will be necessary for staff to assist them to apply Cancer Council 30+ sunscreen.

The goals of the SunSmart Policy are to;

- Increase student and community awareness about skin cancer and sun protection.
- Encourage the entire school community to use a combination of sun protection measures all year round.
- Work towards a safe school environment that provides shade for students, staff and the school community.
- Assist students to be responsible for their own sun protection.
- Ensure that families and new staff are informed of the school's SunSmart policy.

Sun Protection strategies:

- All students and staff use a combination of sun protection measures throughout the day to ensure they are well protected. For example, applying sunscreen, playing in shaded areas and wearing a hat supplied by parents or caregivers. Wide brim hats can be purchased through the P&C uniform shop or purchased from another local retailer. Particular care is taken between 10am and 3 pm when UV levels reach their peak.
- The SunSmart policy is considered when planning all outdoor events such as assemblies, community based programs, camps and sporting events.

Activity Risks & Insurance
